4. Application Fee - \$50.00 cash or check payable to the City of Salida

C. TOTAL SIGN AREA ALLOWED (City Code Table 16-L)

1. Residential Zones and Residential Uses are permitted up to 9 sq. ft. of sign area per dwelling unit.
2. Signs that are painted on, applied or attached to a window that can be read through a window do not count towards aggregate sign area and do not require a permit.
3. Owners of businesses operating in a building in C-1 or C-2 zones may display one sidewalk sign per building on the sidewalk adjacent to the public business entrance of the building. Sidewalk signs are limited in size to a maximum width of 3’ and a maximum height of 5’. Sidewalk signs do not require a permit and do not count towards aggregate sign area. More information on sidewalk signs can be found in Section 16-10-50(d)2 of the Municipal Code.
